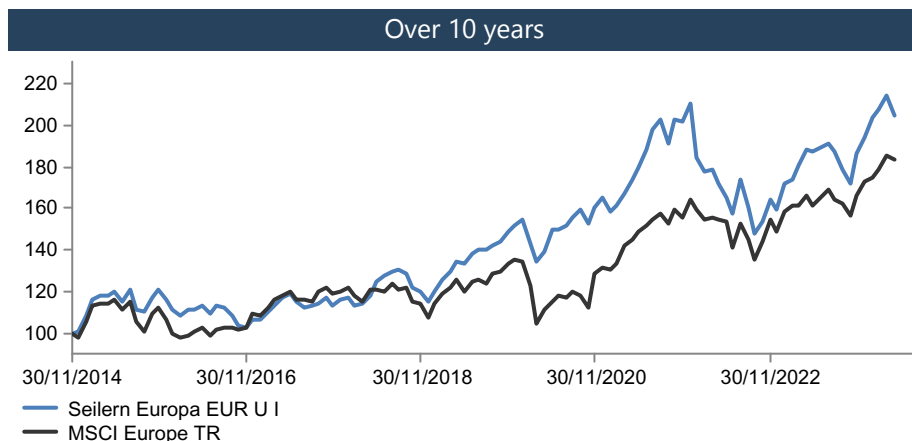
Commentary

Kone was the best performer this month up +6.2%. The company reported decent Q1 results with strong and consistent performance in their service and modernisation markets, which now represent the lion's share of profit. Novo Nordisk was the second-best performer up +2.4%. The company continued to benefit from the momentum gathered following the company's capital markets day in March in which Novo outlined a very bright future for their obesity market. Straumann was the worst performer, falling -14.6%. Although the company reported Q1 sales ahead of expectations, weaker sales in North America and comments around the softer patient flow in the region caused some concern among analysts. Spirax Sarco was the second-worst performer falling -12.0%. There was no company specific news, though broker downgrades and changes in expectations for interest rate cuts both weighed on the share price.

Definitions:

The Seilern Europa EUR U I fund is actively managed and uses the MSCI Europe TR as the benchmark index against which the Fund's performance is compared'. The MSCI Europe Index is an equity benchmark that represents large and mid-cap equity performance across 15 developed markets countries in Europe. "TR" stands for total return, and it assumes any cash distributions, including dividends are reinvested. "CAGR" stands for the compound annual growth rate.
