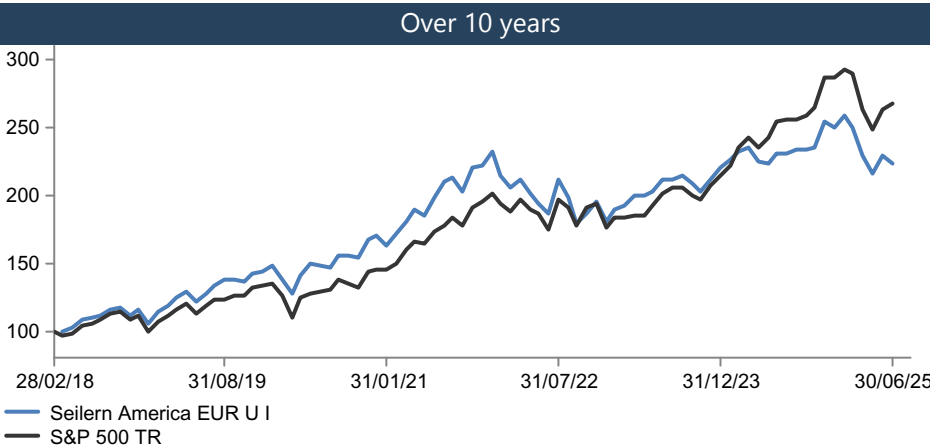
Commentary

Microsoft was the best performer, up +8.05%, lifted by growing investor confidence in its AI strategy and cloud potential alongside several broker upgrades. Cadence was the second best, up +7.34%. The stock rose after reports that Electronic Design Automation (EDA) access was being restored to some Chinese firms, easing prior trade restrictions. Zoetis was the worst performer, down -7.52%, as nervousness around a competing dermatitis drug from Merck nearing EU authorisation weighed on the stock. Adobe was second worst, down -6.80%. Strong Q2 results and raised guidance were not enough to dispel ongoing fears of long-term disruption from AI.
