
Commentary

UnitedHealth was the best performer for the month, up +10.75%. A favourable recommendation for the company in a US Department of Justice lawsuit alleviated perceived legal risk and improved market sentiment. CME was the second-best, up +5.05%. While there was no company specific news during the quarter, the waves of volatility in March benefitted the exchange. Nike was the worst performer, down -19.67%. A combination of an earnings release that saw the time-to-recovery for the business lengthen and macro concerns around global growth weighed heavily on the stock. Intuitive Surgical was the second-worst, down -13.59%. While there was no company specific news, concerns around potential US healthcare reform impacted the stock.
