The fund seeks to achieve growth of your investment by investing mainly in shares (equity) and similar securities issued by high quality companies listed on the stock exchanges of countries within the Organisation for Economic Cooperation and Development (OECD) and, in particular, the U.S. and North American OECD countries.

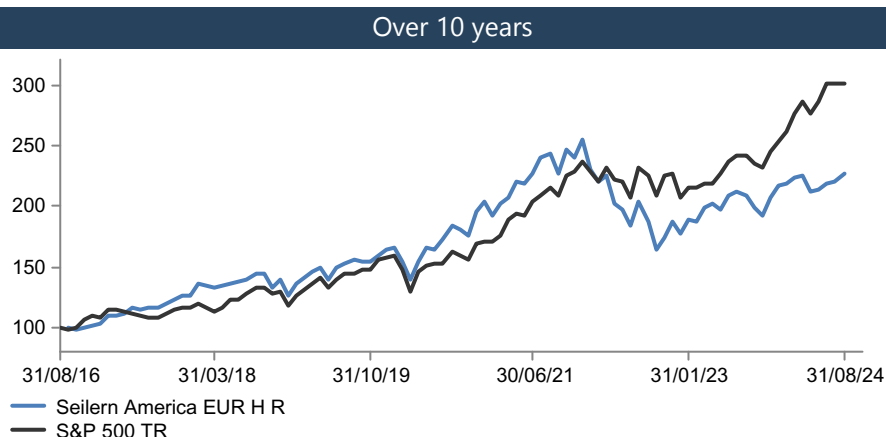
Commentary

An undisclosed position was the best performer this month, up +13.85%. While there was no company-specific news, strong second quarter results in July led to several broker upgrades in August. Nike was the second-best performer, up 12.11%. Although there was no company-specific information, the combination of a weak stock price in July and improving economic sentiment in the US helped the stock. Mettler-Toledo was the worst performer, down -4.67%. Although the company announced strong second quarter results, it guided for slightly weaker-than-expected third quarter sales growth given continued softness in the Chinese laboratory instrument market. Alphabet was second worst, down -4.06%. In August, a US District Court Judge ruled against Google in an antitrust lawsuit concerning its search distribution agreements with Apple, Android OEMs and third-party web browsers. Although the process is far from over, it had a negative impact on the share price.
