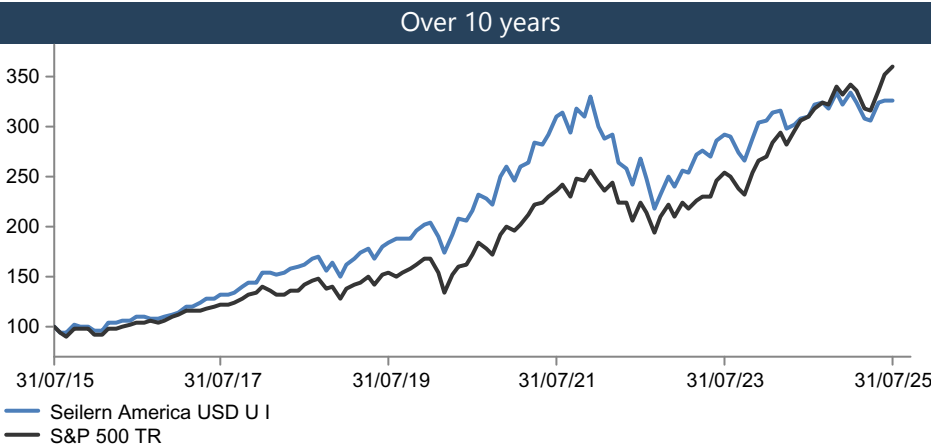
Commentary

Cadence was the best performer, up +18.31%. The stock was lifted by strong H1 results, a solid Q3 outlook, and raised full-year revenue and EPS guidance, despite temporary China export restrictions. West Pharmaceutical Services was the second best, up +9.44%, after a faster-than-expected recovery in its high-value components business prompted the company to raise its full-year revenue and profit guidance. UnitedHealth was the worst performer, down -20.01%, falling on a significant downgrade to its 2025 earnings outlook and a slower-than-expected recovery. Intuitive Surgical was second worst, down -11.47%. Its shares were weak following Q2 results in which lower-than-expected system placements outweighed a solid beat on revenue and EPS and raised full-year guidance.
