### **Investment Objective**

The fund seeks to achieve growth of your investment by investing mainly in shares (equity) and similar securities issued by high quality companies listed on the stock exchanges of countries within the Organisation for Economic Cooperation and Development (OECD) and, in particular, the U.S. and North American OECD countries.

### Commentary

Veeva was the best performer, up +19.69%, after announcing Q1 results well ahead of expectations. Strong growth from their Crossix Data Platform and record margins led to a 13% beat and a 4% increase in FY26 EPS guidance. IDEXX was the second-best, up +18.65%. A slight guidance upgrade and positive commentary on new product launches at their Q1 results defied bearish market expectations and, with the stock at trough valuations, sent shares sharply higher. UnitedHealth was the worst performer, down -26.62%. The company announced the CEO's departure and suspended FY25 guidance due to an acceleration in care activities post its Q1 earnings. Cadence was the second-worst, down -3.58%. The stock fell following news of the Trump administration ordering US EDA firms to stop selling to Chinese customers.
