Investment Objective

The fund seeks to achieve growth of your investment by investing mainly in shares (equity) and similar securities issued by high quality companies listed on the stock exchanges of European countries within the Organisation for Economic Co-operation and Development (OECD).

Commentary

Lonza was the best performer, up +16.9%. They announced the acquisition of a biologics manufacturing site from Roche. As a result, they upgraded their 24-28 sales guidance. The stock also benefitted from various broker upgrades. Inditex was second best, up +13.8%. The company reported strong results for the year and, more importantly, it reported that during the first six weeks of Q1 revenue grew 11% in constant currencies which was substantially ahead of market expectations. Dassault Systèmes was the worst performer down -5.0%. The stock continued to be dragged down by the soft guidance given out in their earnings release last month which was followed by some negative stockbroker reports this month. Kone was second worst, down -4.6%. Negative economic data coming from China continued to weigh on the stock.
