### Investment Objective

The fund seeks to achieve growth of your investment by investing mainly in shares (equity) and similar securities issued by high quality companies listed on the stock exchanges of European countries within the Organisation for Economic Co-operation and Development (OECD).

### Commentary

Belimo was the best performer, up +29.02%. The stock rose sharply following an ad-hoc release in which Q1 sales came in stronger than expected, on robust data centre cooling demand, leading to material full-year guidance upgrades. L'Oreal was the second-best, up +12.88%. The company reported better-than-expected revenue growth for Q1 2025, with all divisions slightly ahead of consensus. Edenred was the worst performer, down -8.55%. An article in the Brazilian press suggesting the government was exploring replacing meal vouchers with its own payment system weighed on the stock despite later suggestions that the plans had been abandoned. Novo Nordisk was the second-worst, down -7.39%. The stock was weak following news of competitor Eli Lilly's positive phase 3 ACHIEVE-1 trial results for orforglipron, its oral GLP-1 compound.
