The fund has adhered to the investment policy and strategy in Q1.

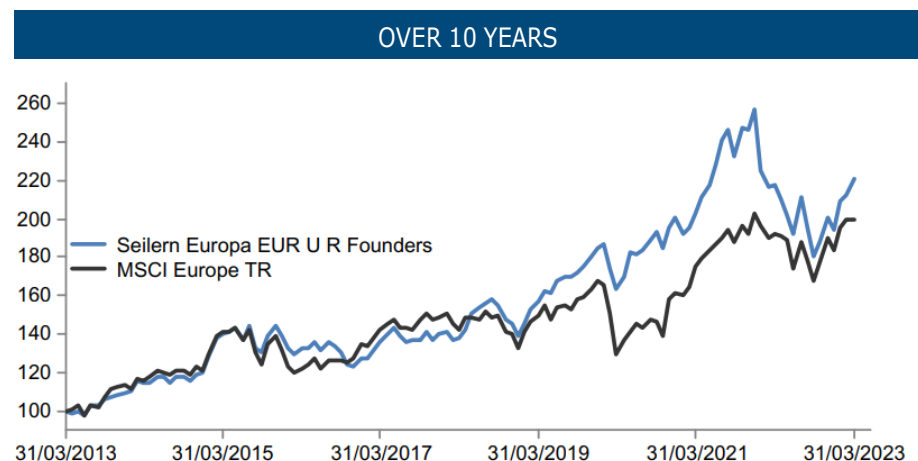
COMMENTARY

Adidas was the best performer, up +14.9%. The market positively digested some of the measures that Management will take to address their inventory issues and weak Chinese growth. L'Oreal was the second best performer, up +9.6%. The company reported strong results for FY22 with balanced growth in all regions and product categories in February, but there was no company specific news in March. SGS was the worst performer, down -6.8%. There was no company-specific news for the month. Intertek was the second worst performer, down -2.9%. The company announced a change in CFO during the month. It also reported full-year results at the end of February in which fourth quarter organic sales growth was below market expectations.

The Seilern Europa Fund (the "Sub-Fund") is a collective investment scheme that is a sub-fund of Seilern International Funds plc (the "Fund"), an open ended investment company umbrella fund with segregated liability between sub-funds, and registered with the Central Bank of Ireland and domiciled in Dublin, Ireland. DEFINITIONS:

The Seilern Europa EUR U R Founders fund is actively managed and uses the MSCI Europe TR as the benchmark index against which the Fund's performance is compared'.
