Objective

The fund seeks to achieve growth of your investment by investing mainly in shares (equity) and similar securities issued by high quality companies listed on the stock exchanges of countries within the Organisation for Economic Cooperation and Development (OECD) and, in particular, the U.S. and Western European OECD countries.

Commentary

Novo Nordisk was the best performer, up +16.7%. The shares rallied on the success of its SELECT study for obesity drug Wegovy, which showed stronger than expected cardiovascular risk benefits. The company also reported strong Q2 results and upgraded its full year guidance. West Pharmaceutical Services was second best, up +10.6%. The stock rose on positive news of favourable trial outcomes for wider use cases of obesity-related drugs, where West helps to manufacture the delivery device components. Estée Lauder was the worst performer, down -10.8%. The company reported Q4 results ahead of expectations but disappointed yet again on its fiscal Q1 guidance. They now expect greater than anticipated pressure on Asia travel retail due to the Daigou crackdown. Spirax-Sarco was second worst, falling -8.9%. They reported earnings that missed expectations and lowered guidance due to ongoing post-Covid related destocking at biopharma customers.

Definitions:

The Seilern World Growth EUR U I fund is actively managed and uses the MSCI World TR as the benchmark index against which the Fund's performance is compared. The MSCI World Index is a broad global equity benchmark that represents large and mid-cap equity performance across 23 developed markets countries. "TR" stands for total return, and it assumes any cash distributions, including dividends are reinvested. "CAGR" stands for the compound annual growth rate.
